

Greetings from the Library!

As you work on your assignments this semester and beyond, you may find that keeping your research organized can be a time-consuming ordeal. The library can help! <u>RefWorks</u> is a web-based bibliography and citation management program that is available to Regis students, faculty and staff. It allows you to:

- Create a personal database of citations and related documents.
- Use folders and tags to organize your resources by themes or topics.
- Import references from online databases, Google Scholar, and other sources.
- Automatically format in-text citations and bibliographies.

Regis College Nursing Student Loan Program

Are you looking for a way to finance your graduate nursing education with low interest rates and the potential for loan forgiveness? If so, the Regis College Nursing Student Loan Program (NSL) is a great option for you.

The NSL offers loans to qualified graduate nursing students at a fixed interest rate of 5%, which is lower than both the Unsubsidized Stafford Loan (7.05%) and the Graduate Plus loan (8.05%). Additionally, NSL loans are forgivable if consolidated with your current federal direct loans.

To be eligible for the NSL, you must be enrolled at least half-time in a graduate nursing program at Regis College and have a demonstrated financial need.

Scholarship Opportunities for Nursing

Students in the Young School of Nursing may be eligible for one of the following scholarships. Please click the links below to learn more details about each scholarship. If interested, you may apply to BOTH scholarships before the **March 15** deadline.

- <u>Mary Jane Scholarship Overview and Application</u>: Opportunity for students studying in the Young School of Nursing, the School of Health Sciences, or in a STEM field in the School of Arts and Sciences. Scholarship awards range from \$1,000 to \$10,000.
- <u>Compassionate Leadership Scholarship Overview and Application</u>: Opportunity for students studying in the Young School of Nursing. Scholarship award is \$5,000.

Important note: Some students may not be eligible to receive this scholarship based on their current financial aid and scholarship package. It is strongly recommended that all students who are interested in applying to this scholarship contact Financial Aid (<u>scholarships@regiscollege.edu</u>) to confirm eligibility before submitting an application.

Whether students have academic or physical accommodation needs, Regis uses an array of resources to support them. Students with disabilities may be eligible for services, and access to these resources can enhance their academic and co-curricular experience.

Examples of disabilities that may be seen on our campus include, but are not limited to:

Learning Disabilities ADD/ADHD, Autism Spectrum Disorder, Dyslexia, Brain Injury, and Neurological Disorder

Psychiatric Disabilities Depression, Anxiety, Bipolar Disorder, and PTSD

Physical/Sensory Disabilities Mobility, Hearing, Speaking, and Vision Limitations

Medical/Temporary Disabilities Chronic Illness, Dietary Restrictions, and Injury

Depending on the unique needs of each student, examples of accommodations include:

- Extended time on tests and exams
- Reduced-distraction testing environment
- Use of assistive technology
- Preferential seating arrangements
- Closed captioning
- Books in alternative formats
- Relocation of a classroom
- Reduced course load
- Housing accommodations



Online Counseling Services
