Are you working on a thesis or scholarly practice project? Do you know how and when you can use copyrighted materials in your work? Copyright can be tricky to navigate and it can be confusing to understand when to request permission to use certain materials (e.g., figures, diagrams, research instruments) in your research. The Massachusetts Loan Repayment Program (MLRP) for Health Professionals

This program is designed to provide financial assistance to healthcare professionals who have outstanding educational loans and are willing to work in underserved areas of the state.

The program is open to physicians (MD/DO), nurse practitioners, physician assistants, certified nurse-midwives, psychiatric nurse specialists, licensed independent clinical social workers, licensed mental health counselors, licensed marriage and family therapists, licensed alcohol and drug counselors, dentists (DDS/DMD), dental hygienists, and pharmacists.

To be eligible for the program, you must have outstanding educational loans, be licensed to practice in Massachusetts, and commit to working full-time in a designated Health Professional Shortage Area (HPSA) or other underserved area for a minimum of two years.

Regis College has partnered with the National Student Clearinghouse to offer electronic official transcripts for current Regis students and former students who attended Regis after 2000. To request an official transcript, <u>click this link</u> or visit <u>Regis Hub</u>. The fee starts at \$5.25.

Please note: At the time of your request, all obligations to Regis College must be cleared, or you will be unable to obtain an official transcript. You can still submit your request, and once your holds have been cleared, your transcript will be processed automatically. After 90 days, your order will be canceled (no charge to your credit card), and you will have to resubmit the request.
