Student-parent applicants are considered for child care assistance through CCAMPIS funding on the basis of eligibility status, financial need, and family contribution levels.

Eligibility guidelines:

1. Undergraduate students must be receiving a PELL grant or be eligible to apply for federal financial aid and voucher amount will be based on the Expected Family Contribution. A FAFSA must be completed and on file with the Office of Financial Aid.
2. Graduate and undocumented students earning their first degree may be eligible to receive CCAMPIS assistance. The Office of Financial Aid will determine if the students Expected Family Contribution (EFC) meets Pell criteria.
3. Child Care must be rendered at a state licensed and accredited center approved by Regis College.

Program expectations:

1. Maintain good academic standing each semester (GPA of 2.0 or higher)
2. Must be currently enrolled in a minimum of 3 credits per semester. Students on formal leave or informal absence are not eligible for funding.
3. Pay the monthly remaining balance for child care programming

The CCAMPIS program will provide child care subsidies of 60%, 40% or 20% (as determined by your EFC) of remaining balance after other vouchers are applied according to the following criteria:
