

## Confidentiality and Privacy

While Regis is committed to maintaining your privacy, certain Regis staff legally must be informed if a Title IX incident has occurred. If you decide to file a criminal report with the police, your name will not be made public—Massachusetts law requires that the identity of an individual reporting a sexual assault be kept confidential in criminal proceedings.

## Student Conduct Amnesty

Regis will not pursue student conduct sanctions for your own use of prohibited or illegal drugs or alcohol occurring in the context of a Title IX incident.

# WHAT IS SEXUAL HARASSMENT?

Sexual harassment is a broad term which includes sexual assault, domestic violence, dating violence, sexual exportation, stalking, or unwelcome contact. Sexual harassment can occur between people who know each other, who are or are not in a relationship, who have previously had consensual sex, between people who do not know each other, people who work together, and others. Sexual harassment is committed by people of all genders, and can happen to anyone. If you have experienced sexual assault or an act of harassment, Regis is here to help you with a variety of on and off campus resources.



## What to Do If You Are Assaulted

### GET MEDICAL ATTENTION

Regis will transport you to a hospital or health professional. Even if there is no obvious sign of physical injury, internal injuries are possible.

### COUNSELING

The crisis intervention and counseling services provided by Regis are available to students regardless of when and where the incident happened.

## How to Report Harassment

You may report incidents of sexual harassment (sexual assault, domestic violence, dating violence, stalking, or unwelcome contact) to Campus Police, Weston Police, the Office of Student Affairs, the Title IX Coordinator, or any other Regis official. You might also consider EthicsPoint, an anonymous online reporting resource, [regiscollege.ethicspoint.com](https://regiscollege.ethicspoint.com). Reporting an incident to the police does not commit you to further legal action or participation in any criminal proceeding. If desired, Regis personnel will assist you in contacting police to file a report. Regis officials who receive a formal report of sexual harassment will inform Campus Police of the incident, but will not include your personal or identifying information without your consent.

## Regis Title IX Investigations

Separate from any criminal investigation, Regis College will respond to all reports of sexual harassment, gender discrimination,

and other concerning conduct on the basis of sex, sexual orientation, or gender identity. Students who wish to move forward with a Title IX Investigation must file a formal report. For information about how to file a formal report, please visit:

## Supportive Measures

Regis will accommodate reasonable changes to a reporting party's and respondent's academic and living situations following an alleged Title IX incident, regardless of the reporting party's decision to report the crime to Campus Police or other law enforcement. These accommodations may include, but are not limited to, a new residential housing assignment, a leave of absence or withdrawal from Regis, Campus Police escorts, parking privileges, Regis-issued no-contact orders, and class schedule modifications. Further, Regis will assist in the enforcement of any lawfully issued restraining orders or orders of protection. In order to provide such accommodations or assistance, Regis may need to disclose a reporting party's or

respondent's identity to certain Regis staff. Such disclosure will be made on a strict need-to-know basis.

If a student has a disability and feels they will need an accommodation during this process, they should immediately contact the Title IX Coordinator at [adam.thrasher@regiscollege.edu](mailto:adam.thrasher@regiscollege.edu) and upon receipt of notice of investigation. All requests for accommodations must be made in writing via email in advance. Consultation may be made with the Office of Accessibility Services regarding any such requests.
