

**Articulation Agreement Between  
Regis College  
And  
Cascadia Community College  
for  
Undergraduate Transfer Students**

This Articulation Agreement (Agreement) is entered into by and between Regis College, 235 Wellesley Street, Weston, MA 02493 (Regis) and Cascadia Community College, 18345 Campus Way NE, Bothell, WA 98011(CCC). Regis and CCC hereby agree as follows.

1. The purpose of this Agreement is to specify the circumstances under which CCC students may transfer into Regis undergraduate bachelor's degree programs.
2. Under this program, students enrolled in CCC will complete a *minimum* of 36 quarter hours (24 semester hours) at CCC after which they may apply for admissions to Regis as transfer students to complete their undergraduate degree program. Of the total number of credits required for an undergraduate degree, a student must complete a *minimum* of 40 credit hours at Regis.
3. Except as stated in Section 4, students from CCC will be guaranteed transfer admission to Regis undergraduate degree programs if they have (a) earned a minimum 2.50 cumulative Grade Point Average (GPA) or the equivalent, and; (b) where applicable, have demonstrated an acceptable score on the Test of English as a Foreign Language (TOEFL) examination.
4. CCC student admission is not guaranteed to the Regis undergraduate programs listed in Exhibit A, attached hereto and hereby incorporated by reference. CCC students applying to the programs listed in Exhibit A will be subject to normal admissions procedures and requirements for those programs, including, but not limited to, GPA requirements, pre-requisite course requirements, and ACT or SAT test requirements. The Regis website and catalog will have the most updated information regarding admissions to these programs. The parties agree to amend and update Exhibit A on an annual basis.
5. Regis will provide admitted students with an evaluation of their progress toward fulfilling Regis undergraduate degree requirements upon their admission to Regis. This evaluation will include an accounting of credits earned at CCC which Regis will accept as transfer credit, the remaining number of credits needed to earn a Regis undergraduate degree, and, where applicable, a preliminary academic plan describing the courses the student will take at Regis.
6. Regis will ensure transferability of all college level credit courses completed at CCC except for remedial courses or English as a Second Language (ESL) courses taken for no credit.
7. The responsibility for the oversight and maintenance of the academic standards will rest with CCC and the Office of Academic Affairs at Regis College.

8. CCC and the Office of Academic Affairs at Regis College will resolve any doubts or concerns regarding quality assurance and monitoring of this program.
9. This Agreement between CCC and Regis becomes effective as of the date of the signatures of both parties. This Agreement may be amended by the written consent of the parties. Either party, with a minimum of ninety (90) days written notice, may terminate this Agreement. At the time of termination, where a CCC student has been guaranteed transfer admissions to Regis or where CCC has notified Regis of a student's intent to transfer, the parties will continue to honor their commitments to such student pursuant to this Agreement.
10. This Agreement is valid for three (3) years from the date it becomes effective. Based upon an evaluation of the progress and quality of the mutual cooperation, this Agreement may be extended for additional three (3) year periods by written consent of the parties.
11. Both CCC and Regis subscribe to a policy of equal opportunity and will not discriminate on the basis of race, gender, religion, national origin, marital status, sexual orientation or physical disability. Regis and CCC shall abide by these principles in the administration of this Agreement, and neither party shall impose criteria for participation in this program which would violate the principles of nondiscrimination.
12. Any marketing materials or publications, whether print or electronic, or other efforts used by either party pursuant to this Agreement must have the prior written approval from the other party before distribution or use.
13. This Agreement supersedes all previous contracts or agreements between the parties with respect to the subject matter hereof, and constitutes the entire agreement between the parties.
14. The invalidity of any provision of this Agreement will not affect the validity of any other provision.
15. This Agreement shall be construed and enforced in accordance with the laws of the Commonwealth of Massachusetts.
