



Articulation Agreement

Between Regis College and Salve Regina University

PURPOSE: To provide qualified students in Regis College's M.A. in Heritage Studies for a Global Society and CAGS in Heritage Studies the opportunity to continue their studies at Salve Regina University to earn a Ph.D.

AGREEMENT: This agreement defines the terms agreed to by the parties regarding graduates of the M.A. in Heritage Studies for a Global Society and C.A.G.S. in Heritage Studies from Regis College to apply to Salve Regina University's Ph.D. program in the Humanities.

- 1. Salve Regina University welcomes applicants for the Ph.D. program from Regis College who have earned the Master of Arts (M.A.) Degree in Heritage Studies for a Global Society or from the Certificate of Advanced Graduate Studies (C.A.G.S.) in Heritage Studies, have maintained an overall GPA of 3.5 or higher, and have been recommended by the director of the M.A. or C.A.G.S. program at Regis College.
- 2. Regis students who have completed HI 601 Fieldwork Methods at Regis College would have met the research methods requirement and would not be required to take HUM 500: Research Methods at Salve Regina.
- 3. Three courses from Regis College's Master of Arts degree (as appropriate) would be applied toward Salve Regina University's concentration requirement. Transfer of credit would be determined by Salve Regina University's Graduate Program Director in Humanities. Students must have earned a grade of B or better in a course for transfer.
- 4. Students who graduate from the Regis College C.A.G.S. program would qualify to have up to three C.A.G.S. courses applied toward the Salve Regina University requirements. Transfer of credit would be determined by Salve Regina University's Graduate Program Director in Humanities. Students must have earned a grade of B or better in a course for transfer.

- 5. The Graduate Record Exam (GRE) requirement will be waived for Regis College students.
- 6. Students who complete a graduate language proficiency in an appropriate language in the Regis College program may have the language proficiency requirement at Salve Regina University waived. Salve Regina University's Graduate Program Director in Humanities will review each request.
- 7. One of the Ph.D. student's dissertation committee members may come from Regis College's graduate faculty.
- 8. Regis College welcomes applicants from Salve Regina University's M.A. Humanities graduates into the CAGS Heritage Studies program based on the recommendation of the Salve Regina University Graduate Program Director in Humanities, and the GRE would be waived.
- 9. This agreement will be reviewed at least every two years and may be revised by mutual consent.
- 10. The agreement may be terminated by either party with not less than one academic semester's notice.
