## 2019 – 2020 Verification Worksheet Independent Student – V1

Your 2019–2020 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before disbursing Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information the financial aid administrator at your school will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the financial aid administrator at your school. Your school may ask for additional information. If you have questions about verification, contact your financial aid administrator as soon as possible so that your financial aid will not be delayed.

1. TAX RETURN FILERS— <b>Important Note:</b> If you (or your spouse, if married) filed, or will file, an <u>amended</u> 2017 IRS tax return, you must contact your financial aid administrator before completing this section.
<b>Instructions</b> : Complete this section if you, the student, <u>filed or will file</u> a 2017 income tax return with the IRS. The best way to verify income is by using the IRS Data Retrieval Tool that is part of FAFSA on the Web. If you have not already used the tool, go to <u>FAFSA.gov</u> , log in to your FAFSA record, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. From there, follow the instructions to determine if you are eligible to use the IRS Data Retrieval Tool to transfer 2017 IRS income tax information into your FAFSA. Retrieving information using the IRS retrieval tool is instantaneous. If you need more information about the IRS Data Retrieval Tool see your financial aid administrator.

Per federal regulations if the student/spouse did not file a 2017 federal tax return the student/spouse must submit a "Verification of Non-filing letter" (VNFL) from the IRS. This letter can be obtained by submitting IRS Form 4506-T with box 7 checked, to the IRS and waiting for the response letter in the mail. You can also attempt to print the 2017 Verification of Non-Filing letter online at <a href="https://www.IRS.gov/transcript">www.IRS.gov/transcript</a> . Once logged into the IRS site, select to print the Verification of Non-Filin letter for 2017.
